## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of Wahkiakum School District No. 200 from September 1, 2013 through August 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Safeguarding IT assets
- Associated Student Body (ASB) fundraising activities
- Payroll – Substitute pay and sick leave cash outs
- Purchasing card disbursements
- Student enrollment reporting
- Procurement of purchases

## INFORMATION ABOUT THE DISTRICT

Wahkiakum School District No. 200 provides public school services to students in kindergarten through 12th grades in Wahkiakum County. Oversight responsibility for the District's operations is vested with an elected, five-member Board of Directors. Board Members are elected to staggered, four-year terms.

The District operates a high school, middle school and elementary school for approximately 420 students. The District has 29 certificated and 29 classified employees. The majority of the District funds come from state funding and local property taxes. The District had budgeted general fund expenditures of approximately \$5.02 million, \$5.52 million, and \$5.64 million for fiscal years 2014, 2015 and 2016, respectively.
